

# Community Forum

## “Pathway of the Prescription”

This training will take you through the pathway of a prescription. First, a physician will review best practices of implementation of the PDMP in practice and outline signs of drug seeking behaviors. Next, an inspector from Bureau of Drug Control will discuss local cases of diversion and a law enforcement agent will discuss what happens once the prescriptions diverts and hits the streets. Then, a treatment director for the Phoenix Center will provide an overview of success stories as well as barriers and challenges of opioid treatment. Lastly, the Coroner’s Office will provide an overview of cases seen in our county. The forum will conclude with the panel of experts answering questions from the audience.

At the conclusion of the program, the participant will be able to:
