## WHY SHOULD YOU ATTEND ?

South Carolina requires pharmacy technicians to complete ten hours of continuing education each license year for renewal; of the 10 hours, a minimum of 4 must be live hours.

## WHO IS IT FOR ?

This course is targeting all Pharmacy Technicians willing and able to continue their education.
